

The first legislation approved addresses HEA provisions related to preparation of K-12 teachers. Postsecondary education is a complex, decentralized enterprise, made up of a wide array of institutions enrolling a large and diverse student body. In academic year 20002001, approximately 6,600 degree- and nondegree-granting postsecondary education institutions were eligible to participate in the HEA s student aid programs. These institutions enrolled an estimated 15.9 million students in the fall of 2000. HEA programs and activities fall primarily into four main categories:
